Supplier Code of Conduct

3.4 Fair Employment and Working Conditions

Suppliers must offer fair employment conditions, provide appropriate compensation, comply with legal working hour limits, and ensure fair termination processes. Basic welfare benefits must be provided as required by law.

3.5 Health, Occupational Safety, and Workplace Safety

Suppliers must ensure a safe working environment, implement risk prevention measures, and manage occupational health responsibly for all employees.

3.6 Environmental Responsibility

Suppliers must conduct operations in an environmentally responsible manner, strictly comply with environmental laws and standards, and promote sustainable resource use.

3.7 Confidentiality and Business Information

Suppliers must safeguard confidential information and intellectual property related to the Company and shall not disclose or use such information without written authorization.

Suppliers are required to acknowledge and sign an acceptance letter of this Code. The Company may revise the contents as necessary and shall inform suppliers accordingly.

This Supplier Code of Conduct is an integral part of the Company's corporate governance and business ethics policy and is effective from January 1, 2025.
