The required documents for consideration

1. The evidence of identity:
 - 1.1 Natural Person: please enclose a certified copy of Identification Card or Passport (in case of foreigner).
 - 1.2 Juristic Person: please enclose a copy of Certificate of Incorporation certified by the authorized person(s) together with its seal affixed (if any) and a certified copy of Identification Card or Passport (in case of foreigner) of such authorized person(s).
2. The evidences confirming the shareholding qualifications, such as the copy of share certificate or the shareholding confirmation documents issued by the securities company or Thailand Securities Depository Company Limited.
3. In case where many shareholders have unified to nominate, one of those shareholders must fill the **Form for nomination of qualified person to be appointed as director** completely and affix the name as evidence. Other shareholders must individually fill in only part (1) of such Form completely and affix the name as evidence. The said Form of each shareholder and evidence of shareholding must be collected and presented together to the Company.
